Regular Meeting April 11, 2024 7:00PM

Mayor Grova called the meeting to order with a flag salute. This meeting was duly advertised in accordance with the Open Public Meetings Law, PL 1975, Chapter 231.

Call of the Roll: Mayor Grova, Mr. Carrow, Mr. Miller, Mr. Corwonski, Miss Renzi. and Mr. Curcio. Also present was Mr. John Moustakas, Solicitor and Engineer, Wayne Johnson.

Mr. Carrow made a motion to accept the resignation of Jennifer Marandino and Mr. Corwonski seconded the motion. All in favor.

The Republican County Committee submitted three names to replace the vacancy council seat, which include the following:

- 1. Stephanie Mazzoni Engle
- 2. Stephen Boyle
- 3. Harold Down

Mr. Carrow made a motion to appoint Stephanie Mazzoni Engle to fill the vacancy and Mr. Curcio seconded the motion. Roll call vote: Unanimous. Motion carried. Mr. Moustakas administered the oath of office.

Mayor Grova advised that Miss Renzi will move to Grants/Economic Development/
Communication and Information Technology Chair and Special Events Committee.
Liaison. He also asked that Mrs. Engle Chair the Public Safety committee and serve as the School Board Liaison.

Public Safety Chair- Chief Decesari provided the monthly police report and advised that the Department appointed a Dave Deegan as Police Chaplain. He brings a great deal of experience from serving as chaplain for the Gloucester County Prosecutor's Office. Officer Zach Pharo was appointed officer of the month. Chief Decesari advised he is looking forward to doing sone programs in the Borough, one being ice cream with a cop and coffee with a cop later in the year. Zach Ellison provided council with the fire call monthly report.

Finance Chair- Mr. Carrow reported that the 2024 budget will be introduced this evening with a 1.5 cent increase along with a water bond for laterals and water meters. Mr. Scharle advised that every \$13,656. Equates to a penny, He stated that this is a very good budget but the increase is due to Liability & Workers Compensation Insurance Increase and The Litigation Emergency from 2023. Mr. Carrow thanked Mr. Scharle and Mrs. Van Camp for their work on the budget.

Grants/Economic Development/ Communication and Information
Technology Chair- Miss Renzi reported the following for the Special Events Committee:

• Yard sale will be held May 4 and flyers will be available for registration for residents

- Movies in the park will be held July 24 and the movie will be Trolls Band Together. Water and cotton candy will be sold.
- Memorial Day service will be held on May 27 at the War Memorial Monument. Church and Arch Streets will be closed off with the assistance of the police department. The committee is currently reviewing the veteran list
- Mr. Berman is retiring at the end of the year. A final draft for the study is due by April 15. A meeting will be held at Delsea Regional High School. It was explained that if regionalization is successful, the borough will then have one seat on the Regional School Board.

Mr. Carrow advised that there will be a be a ten-cent reduction in the school tax due to a reduced enrollment.

Water- Mr. Corwonski reported that he received the approval to plant five trees along Catawba Avenue. There is a stump that needs to be removed on Pearl Street. Mr. Corwonski asked Chief Decesari to assist him with a wire that is hanging on Madison and Franklin avenues. Chief Decesari advised he would have an officer investigate the matter and determine what company needs to be called.

Dog Waste receptacles need to be installed and would like to coordinate with public works.

Mr. Nicholson advised that a fire hydrant was struck by a vehicle on Weymouth Road and within an hour 200,000 gallons of water were lost. A thank you to Mr. Carrow, Peter Sparta, Zach Ellison and Michael Carlino for all of their assistance. The hydrant was replaced yesterday. Mr. Nicholson thanked Mr. Johnson for submitting the monthly reports to the DEP.

License & Inspection/Health & Welfare – Mr. Curcio reported that 12 permits were issued for the month of March totaling \$4,285.

Recycling and Trash/ Buildings, Grounds, Roads Chair- Mr. Miller reported that leaf and limb collection has begun. The recycling center will be open May 4 from 8:00 AM until noon.

Solicitor's Report -Solicitor Moustakas reported that once the cell tower ordinance is adopted the telecommunication tower lease has to be bid. He also noted that he had some items for executive session.

Engineer's Report - Mr. Johnson reported that he inspected the new proposed development on Catawba Avenue. The contractor dug the basin without a performance bond or a preconstruction meeting. They were issued a Red Sticker.

Mr. Johnson advised that he is preparing all of the state reports, water audits and storm water report to be submitted to the state. There is a tree ordinance that has to be adopted in accordance with the storm water permit. It states that if we remove a tree, it must be replaced. We retained \$44,000 from South State to finish the job. We would like to handle the specs for Sandy Drive the same way that we did for Rena Street and Franklin Street.

Public Participation - Mr. Carrow made motion to open the meeting to the public and Mr. Miller seconded the motion. All in favor. No one in the public addressed council. Mr. Carrow made a motion to close the public portion. Mr. Corwonski seconded the motion. All in favor. Motion carried.

Council President Carrow noted that this should not be viewed as a political issue, and asked council to consider it as a service that all of the fire personnel provided from both eras. Mayor Grova and council agreed to authorize Mr. Carrow to proceed with the exploration of the committee.
